



Two Year Extended Warranty Agreement All-In-One Computer

Stinger Medical warrants that all parts of the All-In-One Computer shall be free from defects in material and workmanship under normal use and service for a period of two (2) years from expiration date of the original one (1) year Limited Warranty. If any defects are discovered in the product within that period, Stinger Medical will either repair the defect or replace the product. Stinger Medical will have sole discretion in determining whether a defective product or product part will be either repaired or replaced under this warranty. The buyer is responsible for shipping any defective product or product part to Stinger Medical for repair or replacement. Stinger will ship repaired or replaced product or product part to the buyer at no charge. The Return Merchandise Authorization Form must be completed and submitted via the Stinger Medical website www.stingermedical.com/rma.asp or contact Stinger Medical C.A.R.E, via e-mail C.A.R.E@stingermedical.com or by phone (888) 909-8906.
