



## **MOBIUSPOWER™ Battery Limited Warranty (Patent Pending)**

Stinger Medical warrants that all battery component parts of the MOBIUS POWER System shall be free from defects in material and workmanship under normal use and service for a period of one year from date of purchase. Warranty does not apply to normal wear and tear, normal degradation of the Battery, or if the Battery or any component thereof is opened or repaired by someone not authorized by Stinger Medical, and does not cover replacement of a Battery damaged by: misuse, moisture or liquids, proximity or exposure to heat, accident, abuse, neglect, misapplication, or physical damage.

If any defects are discovered in the product within the specified timeframes (two years for electronic components and one year for battery components), Stinger Medical will either repair the defect or replace the product. Stinger Medical will have sole discretion in determining whether a defective product or product part will be either repaired or replaced under this warranty. The buyer is responsible for shipping any defective product or product part to Stinger Medical for repair or replacement. Stinger Medical will ship repaired or replaced product or product part to the buyer at no charge. All expedited shipping charges are the responsibility of the buyer.
